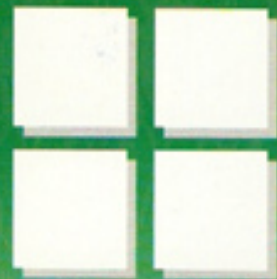

## ROACHES?

Our patented P.E.S.T.® Program eliminates these pests by treating inside the wall voids, equipment, and cracks and crevices where roaches live, breed, and hide.



## RODENTS?

Rats and mice are the pests Americans fear the most, and for good reason. They contaminate food and are capable of transmitting a wide variety of diseases, including salmonella food poisoning.

Some species of mice, especially the deer mouse, transmit the deadly hanta-virus, which is spread through the urine, saliva and feces. Deer mice are found throughout the U.S. in restaurants, nursing homes, and other buildings.

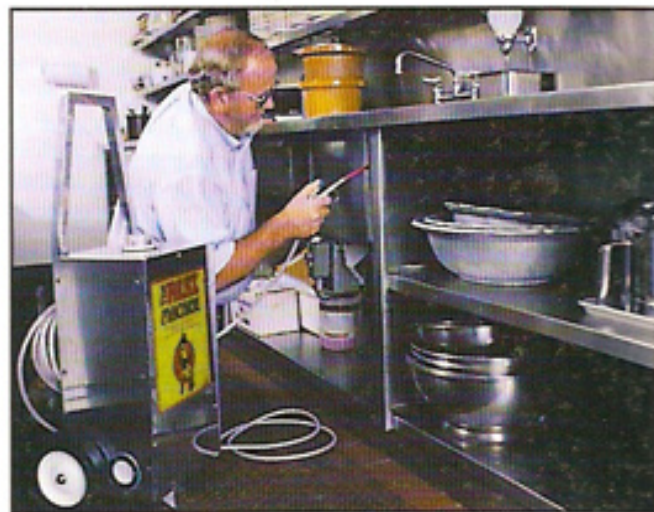

Conventional pest control treatments consist chiefly of spraying liquids, fogging, or use of hand dusters. These applications usually provide unsatisfactory levels of cockroach control due to repellancy, resistance, chemical instability, or the inability to distribute pesticides effectively into roach harborages. Not surprisingly, these methods don't work. Cockroaches



don't live, breed or hide in the open, on floors or baseboards. **Effective treatment must be made where roaches live . . . in their harborages.**

Parker's trained technicians using the P.E.S.T.® Machine solves your roach problems by eliminating them at their source. With this patented new equipment,



boric acid powder (long recognized as one of the most efficient roach toxins) can be applied directly into cracks, crevices, wall voids and all other cockroach harborages at a constant, low pressure. In addition, the P.E.S.T.<sup>®</sup> Machine imparts an electrostatic charge to the powder, causing it to adhere to all interior surfaces as well as to the insects it contacts. Cockroaches will not become immune to it, nor will they be repelled by it, migrating from one part of your building to another. When applied to protected areas, boric acid powder lasts almost indefinitely, continuing to kill cockroaches.

The P.E.S.T.<sup>®</sup> Machine will achieve total control when every possible harborage is treated: walls voids, sub-cabinet voids, hollow doors, baseboards, window and ceiling trim, prep tables, salad bars, tables, chairs, toasters, ovens and any other place where a cockroach might hide. This often includes drilling small holes into wall voids and soffits to allow treatment of these inaccessible areas. With the P.E.S.T.<sup>®</sup> Machine we are able to achieve and maintain 99% plus control, keeping your business roach free, eliminating your worries and allowing you to concentrate on serving your customers.
